- 1) The cooperative is formed without common voting stock. The property rights and interests of each member are equal.
- 2) The members shall decide whether to accept an application for membership. Upon acceptance of an application, the applicant shall immediately become a member. The cooperative may waive the probationary period and accept a member immediately by the affirmative vote of all the members.
- 3) This association is organized with one class of shares, member shares; as of this filing, no member shares have been either subscribed to or paid in.
- 4) Membership shares shall have the following characteristics:
  - Non-assessable
  - Voting - Each membership share equals one vote.
  - The cooperative may later create equity accounts, reserves or distributions, subject to amendment of the bylaws, if growth requires.
  - All shares are non-transferable unless otherwise determined by the Board of Directors.
